



Eligibility Levels for Pregnancy Coverage in Medicaid and CHIP

*Chart updated April 2022

This chart provides eligibility levels for states' Medicaid and Children's Health Insurance Program (CHIP) coverage for pregnancy in 2021. Pregnancy-related Medicaid coverage is mandatory for people earning up to 133 percent of the federal poverty level (FPL), but the majority of states provide optional coverage above that income level. States are also allowed to provide pregnancy-related coverage through CHIP. Under CHIP, states also have the option to provide services during pregnancy through the CHIP "unborn child" coverage option, which may offer a more limited benefit package.
