Building Alternative Finance Mechanism for Sustainable, Rural Health Payment and Delivery Reform: State Participation Survey

Mathematica, the National Academy for State Health Policy and the Rural Health Redesign Center are launching a new project aimed at supporting the development of rural health care payment and delivery reforms that are sustainable, improve patient outcomes, and reduce costs.

This project will convene states and stakeholders to identify and share practical guidance for rural payment reform, which may include a range of efforts such as total cost of care models, global budgets, and capitated and/or risk-sharing models. This project will compliment states' work implementing the Rural Health Transformation Program (RHTP). Even if payment reform was not explicitly a focus of a state's RHTP grant, its investments may provide support that enables rural health systems to engage with alternative payment models. It is an opportunity for state officials to engage their rural health partners to learn and plan together how to move to more sustainable payment.

We are seeking state teams to participate in the project from now through December 2026. Teams should include at least one official representing a key state office with responsibility for rural health (i.e. public health, Medicaid, state rural health office, etc.) along with key stakeholders. Each state can determine the stakeholders most important to their effort, but may include health care providers, payers (i.e. health plans, carriers, etc.), community-based organizations, and/or employer, etc. Designated team leads are not limited to officials from a state office, but may include an official representing a key provider, payer, association, community organization or other stakeholder that will be involved in these efforts.

As a project participant:

- State teams will be invited to a call series that highlights experts in rural health payment and delivery reform and will include opportunities for state-to-state learning.

- State teams will receive an analytic profile of needs and assets to help better understand their current rural health environment and inform opportunities for future reforms.
- Six state teams will be selected to participate in an in-depth gap analysis comparing activities included in their RHTP with the Future of Rural Health Framework – a national roadmap for addressing the needs of evolving rural healthcare systems. The confidential analysis will identify considerations for how alternative payment models can serve as foundational for future rural payment and delivery reform transformation.

Participant teams must demonstrate:

- Past, current, or emerging interest in implementing rural health care payment reform aimed at improving patient care and outcomes while reducing costs.
- Active engagement or willingness to collaborate with stakeholders including payers, providers, employers and/or other community entities on reforms.
- An awareness of specific needs or concerns of their rural health systems, such as specific population health care needs, provider capacity or shortage issues, or known primary cost drivers.
